- TREC funds are formula allocated.
- Colorado to receive approximately \$2.5MM
- Anticipating utilizing funds to support recruitment / retention of HVAC workers to existing workforce training pipelines.
- Aiding upskilling of existing/ incumbent HVAC workforce by subsidizing training / certification / credentialing for HP installers.
- CEO is finalizing grant request submission in January 2024.


- Qualified Contractor List: to be made publicly available and regularly updated
- Potentially including but not limited to:
 - Existing program qualified contractor lists
 - Industry accepted home performance industry credentials
 - Training requirements
 - Business insurance and licensure
 - Skills standards
 - Labor standards
- The following technologies must be installed by a contractor on the qualified contractor list:
 - Electric heat pump for space heating and cooling
 - Air sealing : Virtual post-install inspections are allowed for those places that are difficult to access (e.g., require long-distance travel or travel by airplane or boat).
 - Electrical wiring
 - Electrical load service center / electric panel
